

ORDINANCE NO. 139

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF TERRIL, IOWA, 2000, BY AMENDING PROVISIONS PERTAINING TO WATER RATES

BE IT ENACTED by the City Council of the City of Terril, Iowa:

SECTION 2. SECTION MODIFIED. Section 92.02 of the Code of Ordinances of the City of Terril, Iowa, 2000, is repealed and the following adopted in lieu thereof:

92.02 RATES FOR SERVICE. Water service shall be furnished at the following monthly rates within the City:

(Code of Iowa, Sec. 384.84)

Gallons Used Per Month	Rate
First 1,000 gallons	\$20.00 (minimum bill)
All over 1,000 gallons	\$ 5.00 per 1,000 gallons

SECTION 4. SEVERABILITY CLAUSE. If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

SECTION 5. WHEN EFFECTIVE. This ordinance shall be in effect December 1, 2006.
